Processing of baby diapers (mixing of SAP with fluff (cellulose fibres) and folding with several polymers, lycra, glueing) and packing in the plastic bags; Sanitary napkin processing (mixing of SAP with fluff (cellulose fibres) and folding sanitary napkin with several nonwoven materials (polypropylene, polyethylene), adhesives and setting siliconised protective paper, cutting out the final shape and packing into plastic bags. Cosmetic wet wipe processing (mixing the lotion and applying it to non-woven material, cutting and forming) and packaging in plastic film with the addition of a lid or label Stain removal wet wipes (mixing the lotion and applying it to non-woven material, cutting and forming) and packing into plastic film Wet toilet paper processing (mixing of lotion and applying on flushable material) and packing into plastic film; Processing of liquid soaps, shampoos, light and heavy-duty liquid detergents, fabric conditioners, all-purpose cleaners, and window cleaners by mixing liquid chemical ingredients and filling them in plastic bottles, or in water-soluble PVA/PVOH film capsules.
